POSTAL BALLOT NOTICE

Members of the Company are hereby informed that pursuant to Section 110 and other applicable provisions, if any, of Companies Act, 2013 read with Rule 22 of Companies (Management & Administration) Rules, 2014 as amended from time to time read with the latest General Circular No. 39/2020 dated December 31, 2020 and the rules made thereunder on account of the threat posed by COVID-19 issued by the Ministry of Corporate Affairs ('MCA Circulars') and pursuant to the other applicable laws and regulations, the Company shall seek approval of its members by way of Postal Ballot in respect of the special business set out in the Postal Ballot Notice dated February 15, 2021 (Postal Ballot Notice).

In terms of MCA Circulars and on account of the threat posed by COVID-19 pandemic, the Company will send the Postal Ballot notice in electronic form only and the communication of the assent or the dissent of the members will also take place only through the remote e-voting system.

The Company has on February 15, 2021 completed dispatching of Postal Ballot Notice by email only to the members whose names appear in the Register of members/List of Beneficial Owners as received from NSDL and CDSL and whose email addresses are available with the Company as on (Friday), February 12, 2021 ('cut-off date').

The Company seeks consent of the members by way of Ordinary/Special Resolutions on the matters mentioned in the Postal Ballot Notice through remote e-voting only. A copy of Postal Ballot Notice is also available on the website of the company www.rungtairrigation.in and on the website(s) of the stock exchange i.e. BSE Limited at www.bseindia.com, where the company's shares are listed and on the website of CDSL www.evotingindia.com.

Please note that in compliance with the provisions of section 108, 110 and other applicable provisions of the Companies Act, 2013 read with (i) Rule 20 and Rule 22 of the rules as amended (ii) Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and (iii) MCA circulars, the company has provided only the remote e-voting facility to its Members, to enable them to cast their votes electronically instead of submitting the Postal Ballot form. The company has engaged the services of CDSL for providing remote e-voting facilities to the Members, enabling them to cast their vote electronically and in a secure manner.

The members, who are holding shares in physical/electronic form and whose email addresses are not registered, shall register their email-id with the Registrar and Transfer Agent of the Company/their respective Depository participants. The members holding shares in physical form are requested to register their email addresses at the earliest by sending scanned copy of a duly signed letter by the member(s) mentioning their name, complete address, folio number, number of shares held with the Company along with self-attested scanned copy of the PAN Card, Aadhaar Card or any other Govt. document in support of the address proof of the member as registered with the Company for receiving the Postal Ballot Notice by email to our Registrar and Transfer Agent of the Company, M/S Beetle Financial & Computer Services Private Limited at beetlealta@gmail.com. Members holding shares in demat form can update their email address with the Depository Participants. The notice of the Postal Ballot shall contain all the instructions regarding the manner in which the members can cast their vote through remote e-voting.

M/s NPS and Associates, Practicing Company Secretaries, has been appointed as the Scrutinizer for conducting the Postal Ballot process in a fair and transparent manner. The remote e-voting period shall commence on February 16, 2021 at 10:00 A.M. and end on March 17, 2021 at 5:00 P.M. The remote e-voting shall not be allowed beyond 5:00 P.M. on March 17, 2021.

If any Member casts his vote by remote e-voting after 5:00 P.M. on March 17, 2021 (i.e. after 30 days from the date of dispatch of notice), then that remote e-voting will not be considered as valid vote and will be treated as if reply from such member has not been received. Members who have not received Postal Ballot Forms, may apply to the company and can obtain a duplicate thereof.

The result of the Postal Ballot will be declared on or before 5:00 P.M. on Thursday, March 18, 2021. The aforesaid result along with the Scrutinizer's report would be displayed on the Company's website www.rungtairrigation.in and on the website of CDSL www.evotingindia.com immediately after the result is declared. The Company will simultaneously forward the results to the Stock Exchanges where the shares of the Company are listed.
